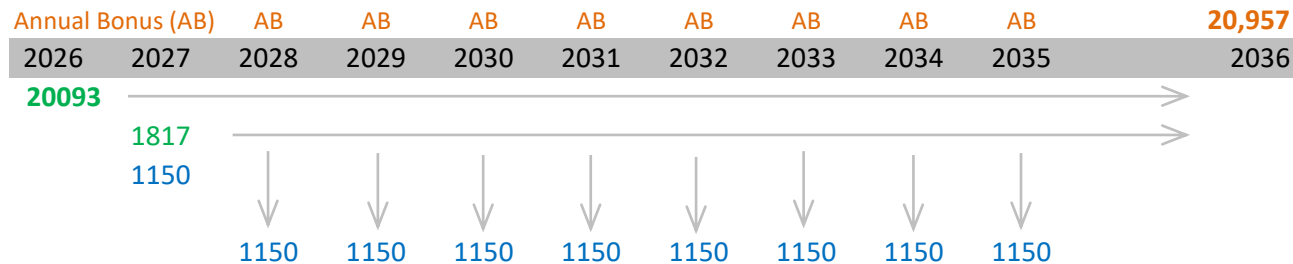

### Remarks:

Total funds put into savings plan is  $20093 + 1817 * 1 = 21910$

Assumption - cashbacks of \$1,150 on 2027 year are used to offset partial premium and receive  $\$1,150 * 8 + \$20,957 = \$30,157$

Option to accumulate all future cashbacks at 3.0%p.a. and mature with \$32,991, by paying full premium of \$2,967 on 2027 year
