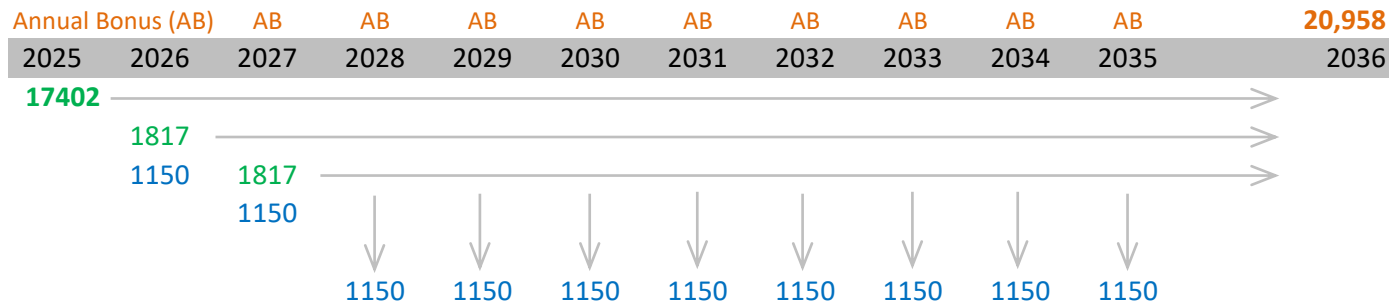

Remarks:
