

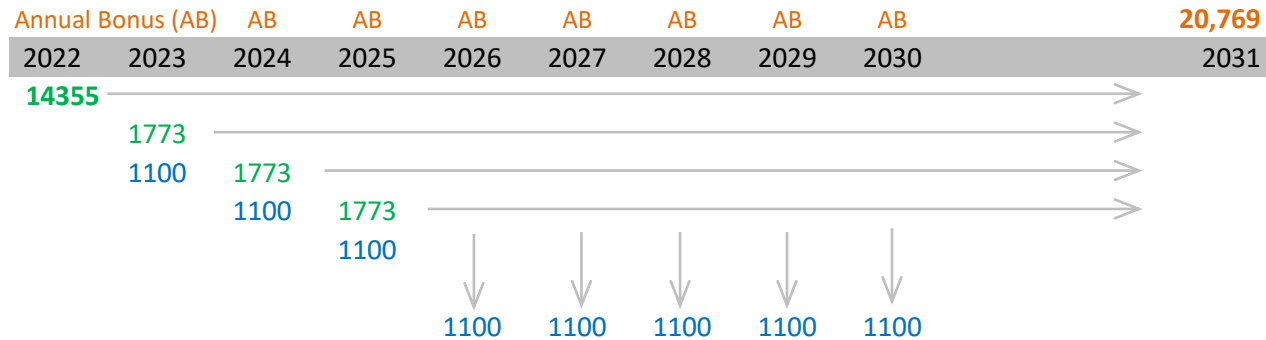

**Remarks:**

Option to accumulate all future cashbacks at 3.00%p.a. and mature with \$30,844, by paying full premium of \$2,873 from 2023-2025
