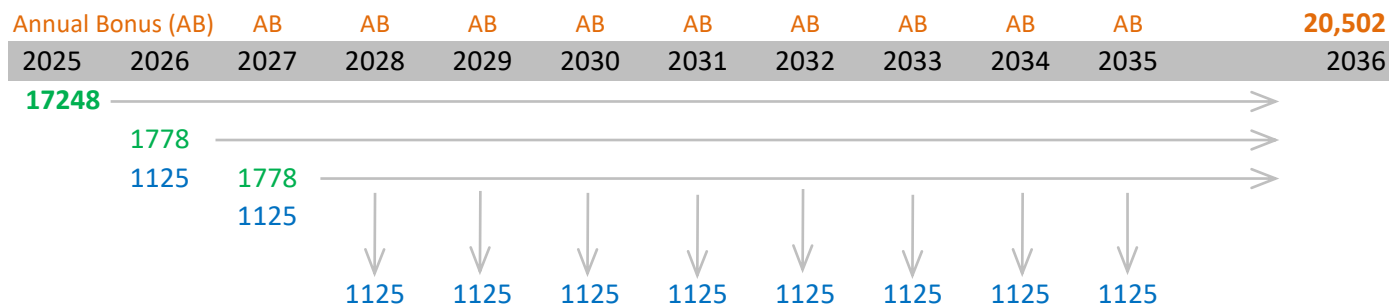

## Remarks:
